

# TINY TREASURES CHRISTMAS ARTISTS' SALE 2020

## TERMS AND CONDITIONS

### **Regional Criteria:**

Artists living, working or studying within the Peel Region can apply to be part of the Tiny Treasures exhibition. No regional restrictions apply to applicants for the associated Tiny Treasures Art Market.

### **Artwork:**

- Is 2 or 3 dimensional not exceeding 30cm x 30cm x 30cm
- Is original and of quality craftsmanship
- Is suitably presented with no wear and tear
- Meets appropriate health and safety standards
- Is priced not to exceed \$300
- 2D works are fitted with appropriate hanging devices no less than 50mm from top of the artwork
- Delivery is the responsibility of the artist
- Each work is labelled with your name code and sale price on a removable sticker or swing tag, firmly attached but not glued to the back or underneath the artwork
- Is catalogued on an electronic stock sheet that includes the name code and price, as directed and supplied by CASM
- If deemed inappropriate will be excluded from the exhibition

Artists supplying small works such as jewellery are to consider gallery presentation and provide simple elegant props if necessary – visit gallery to discuss

### **Responsibility:**

- CASM will take all due care with your work however takes no responsibility for the insurance of your artwork. CASM will not be held liable for damage or theft over the course of the exhibition.

### **Sales and Commission:**

- All artwork must be available for sale
- The sale price will include 20% commission payable to Contemporary Art Spaces Mandurah
- Artists will supply an ABN or Statement of Supplier Form to CASM with delivery of artwork
- Artists will be notified when more stock is needed and will be presented with monies from the works by February 2020
- An exhibition entry fee of \$20 is payable from successful applicants, due at the time of artwork delivery.

### **Copyright:**

- Copyright remains with the artist but the artist will extend the right for CASM to use the images of the artworks for promotion and educational purposes.

**Gallery Sitting:**

- Sitting the gallery during the exhibition is a great opportunity to observe how your work is received and to engage with your audience. Successful artists are invited to attend the gallery for 3 hour shifts during the exhibition to assist gallery staff and volunteers greet, serve and wrap purchases for customers. A roster will be available on the artwork delivery day.
