

Christmas in Mandurah Window Competition 2022 - Terms and Conditions

Information regarding prizes and how to enter forms part of these Terms & Conditions. By entering, entrants accept these Terms & Conditions.

- 1. The "Promoter" is City of Mandurah ABN 43 188 356 365.
- 2. The competition is open to businesses physically located within the City Centre area of the City of Mandurah.
- 3. "City Centre" is defined as the area bounded by Hall Park (Western Foreshore) to the South; and the eastern and southern boundaries follow part of Pinjarra Road, Sutton Street, Eastern Foreshore, Boardwalk Precinct, Civic precinct, and Mandurah Ocean Marina.
- 4. Businesses must register with the Promoter in order to be included in the voting options.
- 5. Businesses are responsible for creating their own window display, and are permitted to advertise their shopfront in order to encourage voting.
- 6. The competition voting period commences 1 December 2022 and closes 31 December 2022, 12:00am WST. The winners will be announced in January 2023, at the City of Mandurah Administration Building, 3 Peel Street, Mandurah WA 6210
- 7. There will be three winners ("Winner") with first, second and third place awards based on the votes received. The Promoter's decision is final and no correspondence will be entered into.
- 8. Each winner will receive an advertising package, with a total business prize pool of over \$9,000 ("Prizes").
- 9. The Prizes are not transferable, exchangeable or redeemable for cash.
- 10. Prizes which are lost, stolen or misplaced will not be replaced or reissued.
- 11. The Winner will be notified in January 2023, by telephone or email. The Promoter will make all reasonable attempts to contact the winner until 4:00pm on the day which is 7 days after the Winners are announced. If the Promoter is unable to contact them the next winner down the line will be contacted based on the number of votes received. If required, this process will be repeated as long as needed until all prizes have been awarded. If requested, the Winner must provide photo identification when receiving the Prize.
- 12. Except for any liability that cannot be excluded by law, the Promoter (including their officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of this promotion, including, but not limited to, (a) any technical difficulties or equipment malfunction; (b) any theft, unauthorized access or third party interference; (c) any Entry or Prize claim that is late, lost, altered, damaged or misdirected.
