

Shop and Win Competition February 2023 - Terms and Conditions

Information regarding prizes and how to enter forms part of these Terms & Conditions. By entering the Competition, the Entrant accepts these Terms & Conditions.

- 1. The "City" refers to the City of Mandurah (ABN 43 188 356 365).
- 2. The City is the organiser and promoter of the Shop and Win Competition ("Competition").
- 3. The "Entrant" relates to the person who is entering the Competition via the survey link.
- 4. An "Entry" means any entry in the Competition competing for the Prize ("Prize") as set out in the messaging of that Competition.
- 5. An "Eligible City Centre business" means any business, excluding supermarkets or purchases for take-home alcohol, within the area bounded by Hall Park (Western Foreshore) to the South; and the eastern and southern boundaries follow part of Pinjarra Road, Sutton Street, Eastern Foreshore, Boardwalk Precinct, Civic precinct, and Mandurah Ocean Marina.
- 6. The "Winner" refers to the Entrant/s selected and allocated the Prize/s.
- 7. The total prize pool is \$3,000 in local business vouchers.
- 8. Winners will be chosen at random from a database of all eligible Entries received. The City's decision on the Winners is final and no correspondence will be entered into.
- 9. The Competition period commences 1 February 2023 from 00:01am to 28 February 2023 11:59pm WST. The Winners will be announced in March 2023 ("Draw Date"), at the City of Mandurah Administration Building, 3 Peel Street, Mandurah WA 6210.
- 10. The City will make all reasonable attempts to contact the Winner from the Draw Date. If the City has been unable to contact the Winner within a reasonable timeframe which allows for a secondary Winner to be notified, then the Winner will forfeit their Prize. The City will endeavour to redraw a new Winner of the forfeited Prize.
- 11. The City in their absolute discretion, may disqualify Entrants and/or Winners who bring the Competition into disrepute.
- 12. To the full extent permitted by the law, the City will not be liable for any injury, damages, expenses, or loss whatsoever (whether direct or consequential) to people or property as a result of any person entering into the Competition or accepting or using any Prize, including without limitation, non-receipt of any Prize or damage to any Prize in transit.
- 13. Entry is only valid and accepted if a purchase over the value of \$10 is made at any eligible City Centre business, and a copy of the receipt and Entrant contact details is submitted within the designated timeframe set out in the Competition description. One Entry limit per transaction.
- 14. Entrants under 18 years of age need to have the consent of their parent or guardian to enter.
- 15. The City reserves the right to photograph and/or video-record the Winners' Prize collection and use the subsequent images for promotional purposes.
