## APPLICATION FOR VEHICLE ACCESS TO COUNCIL RESERVE/BEACH

#### **Conditions of Access**

No more than two (2) vehicles/trailers on the reserve/beach at any one time and must only be vehicles necessary to set up or run an event. Where possible the vehicle should be removed after equipment is dropped off.

Vehicle/s are not permitted to travel at speeds greater than 10km per hour.

Vehicle drivers must be licensed in accordance with the Road Traffic Act.

Where practicable, vehicles must avoid all playing surfaces and must not be driven within 20 meters of any other reserve/beach users.

Vehicles must be driven in broad gentle turning circles to limit tyre damage to the turf surface and driving over dunes is strictly prohibited.

Any damage resulting from a vehicle being driven on the reserve/beach however caused will be repaired by Council and at the operators/clubs expense. Costs will be recovered either by invoice or bond monies being withheld.

Any damage as a result of gates not being locked at the conclusion of the event will be repaired by Council and at the operators/clubs expense. Costs will be recovered either by invoice or bond monies being withheld.

All instances of damage deemed hazardous/dangerous must be reported to the City of Mandurah immediately.

The City reserves the right to withdraw or vary these arrangements at any time without prior notice.

Council considers maintaining the quality and condition of the City's property for the use of all community groups a high priority. Please ensure that maintenance issues are brought to our attention e.g. damaged fences, defaced signs, etc. It is also requested that the reserve be left in a clean and tidy condition at the conclusion of your event and that all rubbish be removed from the area.
