

## Eligible Items

### Formation of new Clubs

- Incorporation costs (Fees to lodge a Constitution)
- Setup stationery costs (Letterhead or logo design)
- Setup equipment
- Stationary or office equipment

### Volunteer Training and Workshops

- Approved coaching or referee courses
- Training seminars, such as first aid or strapping courses
- Committee webinars

### Safety Items

- Safety equipment such as goal padding, head gear, stretcher
- First aid items.

### Promotion and Marketing

- Advertising costs to promote the club
- Hire of equipment at club promotional event, such as marquees
- Facility hire
- Signage and banners to promote the club

### Inclusion Projects

- Printing and advertising
- Project facilitator fees i.e specialised coach
- Equipment specific to the project

## Non-Eligible Items

- Ongoing costs
- Wages or honorariums
- Items which only benefit individual members
- First aid items to top up kits
- Items funded the previous year
- Standard sports equipment
