

Museum 'Creatures of our City' Colouring Competition

Terms and conditions

Participation in the competition is deemed as acceptance of these Terms and Conditions:

- 1. The "City" refers to the City of Mandurah.
- 2. The "Competition" refers to the Museum 'Creatures of our City' Colouring Competition organised by the City.
- 3. The "Entrant" refers to the child (12 years old and under) and their parent/guardian who is entering the Competition.
- 4. The "Prizes" relates to the three prizes available and allocated to three age groups:
 - 1. 5 years and under prize: Australian Animal Bucket valued at \$19.00
 - 2. 6-9 years prize: Small Brown Turtle valued at \$18.95
 - 3. 10-12 years prize: Wombat Stew Book valued at \$10.00

Total prize pool value: \$47.95. (All prizes are as stated and are not exchangeable for cash.)

- 5. The closing date ("Closing Date") of the Competition is Friday, 25 July 2025, 4pm.
- 6. A "Valid Entry" means a colouring page with completed contact details and submitted to the City of Mandurah Museum, 3 Pinjarra Rd, Mandurah WA 6210, by the Closing Date.
- 7. Only one Valid Entry will be accepted per Entrant.
- 8. The "Winners" refers to the Entrants selected and allocated the Prize from each category.
- 9. Winners will be chosen by the City based on the best judged entry for each age category. The judging will take place at the City of Mandurah Museum at the conclusion of the competition. The judging will be final and no correspondence will be entered into.
- 10. Winners will be notified by phone by Thursday 31 July 2025. If the Winner does not make contact with the City by Thursday 31 July 2025 4pm, then the Winner will forfeit their Prize and the City may, in its sole discretion, redraw a new Winner of the forfeited Prize.
- 11. The City, in their absolute discretion, may disqualify Entrants and/or Winners who bring the Competition into disrepute or who breach these terms and conditions.
- 12. Except for any liability that cannot be excluded by law, all prize winners shall indemnify the City from all claims, costs, losses (whether direct or indirect) including any interest, injury or death, penalties, legal and other professional fees and expenses awarded against or incurred by the winner as a result of their use of their prize.
- 13. The City retains ownership of the intellectual property that it has specifically developed in relation to this competition. All other intellectual property remains the property of the creator.
- 14. City of Mandurah Elected Members, employees and family members are ineligible to enter.
- 15. The City reserves the right to photograph and/or video-record the Winners' prize collection and use the subsequent images for promotional purposes.
- 16. The City reserves the right to cancel, suspend or terminate the Competition without notice.
- 17. Any personal information collected in the Competition will solely be used for purposes connected to this Competition. Entry is conditional in providing this information.
