There are now three types of dangerous dogs, and they are as follows:

- **Dangerous dog (declared)** – is a dog that through its actions has been declared a dangerous dog by a Local Government in accordance with section 33E(1) of the Act;
- **Dangerous dog (restricted breed)** – is a dog prescribed in the Dog Act Regulations as a restricted breed and includes but is not restricted to Pit Bulls, American Pit Bulls and or mixed breed of those dogs named;
- **Dangerous dog (commercial security)** – is a dog that is used to guard commercial properties but not a residential property.
- All dangerous dogs must be microchipped. The owner must provide details of the microchip company and allocated identification number to the City. The owner of a dangerous dog can obtain an exemption certificate from a veterinarian if the micro-chipping of the dog will have an adverse affect on the dog's health and welfare. The certificate must be provided to the City for verification.
- The owner of a dangerous dog (declared) must notify the City of any change in ownership and must also notify the new owner of the conditions under which a dangerous dog must be kept.
- The owner of a dangerous dog (restricted breed) or its pups must not sell those dogs/pups to another person. The breeding of restricted breeds is prohibited.
- All dangerous dogs (restricted breed) must be sterilised immediately and the owner must provide a veterinarian certificate to the local government for verification.
- Only two dangerous dogs, whether declared or a restricted breed, may be owned and registered at one property.
- Dangerous dogs – declared and restricted must wear a collar as prescribed in the Dog Act Regulations, wear a muzzle that prevents the dog from attacking or biting and be kept on a suitable leash under the control of a person over the age of 18 years and that person must be capable of controlling the dog at all times when in a public place. A dangerous dog must be maintained on a leash when in an allocated dog exercise area.
- Dangerous dogs must be kept in a child and escape proof enclosure. The person liable for the control of a dangerous dog must ensure that the enclosure within which the dog is confined, whether or not the enclosure is at the premises where the dog is ordinarily kept or ordinarily permitted to live, is constructed to:
  - (a) Prevent the dog from escaping; and
  - (b) Prevent the dog from being removed or released from the enclosure without the permission of the person liable for the dog's control; and
  - (c) Prevent a child who has not reached seven years of age from entering or inserting any part of its body into the enclosure without the help of an adult.
- Penalties for alleged offences against a dangerous dog, declared or restricted breed, have increased significantly.
