I ("the Member"), hereby apply for membership to the City of Mandurah Seniors Centre ("the Seniors Centre"), managed by the City of Mandurah ("the City"), located at 41 Ormsby Terrace, Mandurah, Western Australia. I have read and agree to the following terms and conditions ("Terms and Conditions"):

1. Membership Duration

Membership lasts for 1 year from the day I pay, and membership fees are to be paid in full when I sign-up.

2. Membership Card

I will scan my membership card at the front desk staff each time I enter the centre. If I misplace my card I understand there may be a fee for a replacement.

3. Who Can Use the Membership

My membership is just for me. No one else can use my card or membership benefits. My membership entitles me to bring guests (non-members) to the Seniors Centre by paying a daily fee per guest.

4. Programs and Activities

My membership allows me to join Seniors Centre classes, programs, and activities (see [Seniors Activities Timetable](#)), and I understand some of these may cost extra. Staff will advise any additional costs in advance.

5. Members Services

My membership includes access to members services such as a podiatrist, chiropractor, hairdresser etc. (see [Seniors Members Services](#)) and access to the Seniors Centre bus service, within the City of Mandurah boundary, for a small fee.

6. Behaviour and Safety

Whilst at the Seniors Centre, I will comply with all rules and local laws about respectful behaviour ([Code of Conduct](#)), appropriate clothing, and safe use of equipment and services. I will follow all instructions from City staff. These rules help keep the centre safe and enjoyable for everyone.

7. Health and Participation

Some activities may involve physical movement, and I confirm I am healthy enough to join these types of activities. I am responsible for managing my own medical conditions.

8. Changes to Terms and Conditions

These Terms and Conditions may be updated from time to time, and I will be notified of any changes.

9. Centre Closures

Sometimes the Seniors Centre may close due to unforeseen circumstances (e.g. for maintenance or emergencies). The Seniors Centre is not liable for any loss or inconvenience during such closures.

10. Non-refundable

I have 7 days after joining to change my mind and cancel my membership. After 7 days, the membership fee is non-refundable and I understand my membership cannot be suspended for any reason (including medical or travel).

11. Cancellation

If I do not follow these Terms and Conditions, the City may cancel my membership.

12. Indemnity

I agree to indemnify the City, all its officers, agents and employees in respect of any claim arising from any event that occurs whilst I am present at or utilising the services or any facilities of the Seniors Centre. This includes any damage to property or any accident, injury or loss suffered by me or any person in my care and control. I also release the City from all liability for such events, except where any injury or loss is directly caused as a result of the City's negligence.
